Terms and Conditions

Administrator: refers to the person that represents the **Club** in interacting or dealing with the **Provider**.

ASA: the statutory body known as Athletics South Africa

Club: refers to an entity that represents a group of people that will share certain information in relation to information printed on the sticker. A club normally relates to an entity registered with **ASA**.

Delivery Address: refers to the address of the **Club** that is maintained by the **Administrator** with its account on the **Website**

Member: refers to the person that is associated with a **Club**

Provider: refers to the company Running Sticker (Pty) Ltd, registration number 2017/142682/07

Running Sticker: refers to the sticker that contains information about the person which will be used to represent the athlete's information on the race entry

Website: refers to the website of the **Provider** being <http://www.runningsticker.co.za>

Terms and Conditions relevant to the Provider

1. The **Provider** shall make available a website on which the the **Administrator** will be able to edit and maintain information about the **Club's** information and engagement with the **Provider**
2. The **Provider** shall ensure that all information about **Members** in its database be kept safe from intrusion through means of hacking, or any means otherwise. The **Provider** commits that the information shall be protected through the implementation of all necessary safeguards and mechanisms to ensure the safety of **Members'** information.
3. The **Provider** confirms that no **Member** information shall be shared with any third party at any given time.
4. The **Provider** shall process any bulk request for the printing of **Running Stickers** in a reasonable period of time, which period shall not exceed 7 calendar days.
5. The **Provider** shall ensure that any **Running Sticker** that is produced shall be according to the information that is contained in the **Website's** database.
6. A set of **Running Stickers** produced for a **Member** shall be packaged in such a way that the **Administrator** can easily distribute the **Running Stickers** to the **Members**
7. The delivery of a batch of **Running Stickers** shall take place to the address as contained on the **Provider's Website** at time of production. The **Delivery Address** shall not be modified once shipment with the courier company has been arranged.
8. The **Provider** shall make any information required by the **Administrator** available on its **Website**.
9. The **Provider** shall implement a mechanism for special authorisation, i.e. a One Time Pin sent via SMS, for any activity that is deemed to incur significant commitment to the **Club**. As example, the approval of a batch process for **Running Stickers** shall be governed through this mechanism.

Terms and Conditions relevant to the Club

10. The **Club** shall nominate an **Administrator** that shall coordinate all interaction with the **Provider**.
11. The **Club** shall ensure that its information as contained on the **Website** shall be maintained at all times.
12. The **Club** shall not hold the **Provider** liable for any loss incurred, or costs incurred as a result of incorrect information as contained in the **Website's** database.
13. The **Club** agrees to the processes implemented by the **Provider** to solicit or confirm information from the **Member** in order to ensure correct information to be printed on the **Running Sticker**. This may include the sending of a SMS message to the **Member** with a request to confirm information.
14. The **Club** agrees that aforementioned mechanism will be communicated to its members whereby they can expect these messages from the **Provider**.
15. The **Club** shall not hold the **Provider** liable for any costs or loss due to incorrect information provided to the **Provider**. This pertains specifically to **Member** information to be printed on the **Running Sticker**.
16. The **Club** agrees that the **Provider** shall invoice the same at the current rate for printing the **Running Stickers** for its members.
17. The **Club** agrees that printing of the **Running Stickers** shall only commence once payment for the order is reflecting in the **Provider's** bank account.
18. The **Club**, or its **Members**, shall not hold the **Provider** liable for damages if the **Website** suffers a cyber attack and the **Website's** database contents becomes available as a result of such an event.
19. The **Administrator** shall keep his login credentials secure and not share it with anyone.
20. The **Club** agrees that any changes to information made, making use of the **Administrator's** login credentials shall be binding on the **Club**.
21. The **Club** shall remain liable for the production cost once a batch job has been submitted, approved and processed through the **Administrator** account.
22. The **Club** agrees that the **Provider** may contact the **Administrator** on occasion with requests and reminders regarding the ordering of **Running Stickers**.
